

# UK Press Card



The BAJ is part of the 'UK Press Card Authority' who issue through Gatekeepers the only UK Press ID formally recognised by all Police forces in the UK and other public bodies. The UK PRESS CARD is an essential ID verifier for journalists and news-gatherers while on assignment. A two year Press Card is available to BAJ members or freelance members of the media who need to identify themselves in public as working members of the press.\* – The card carries the issuing gatekeepers logo in the top right-hand corner, with multiple built-in security features that can be quickly verified by the Police and public bodies.

A fee of £35.00 is charged to issue, renew or replace a two year UK Press Card.

The cost of a two year UK Press Card to non-members is £80.00.\*\*

## NOTE

### **We do not issue UK Press Cards to Vloggers or Bloggers**

\* 'UK Press Cards' are subject to meeting strict criteria laid down by the UK Press Card Authority that the BAJ must follow for the issue of PRESS ID. Membership of the BAJ does **NOT** guarantee entitlement. Please allow ten working days for your application to be reviewed, verified and processed.

\*\* applications for a UK Press Card will only be accepted if accompanied by the following;

- Proof of identity, e.g. certified copy of a passport, driving licence etc. together with proof of home address.
- Samples of verifiable published paid journalistic work.
- Verifiable **original** signed letter on **official headed paper**, from the editor or managing editor of a **recognised UK national or regional media outlet**, certifying that the applicant produces paid work for them regularly. **Applicants can not supply letters signed by themselves.**
- A passport style image of yourself.
- **Altered or forged documents shall be considered an attempt to obtain UK Press accreditation fraudulently and reported to the police.**



# British Association of Journalists

## UK Press Card Scheme

BAJ is a Gatekeeper and director of the UK Press Card Authority, empowered to issue UK Press Cards to BAJ members and associates who are full-time media professionals in an editorial work-flow process.

The UK Press Card is recognised by police forces throughout the UK and by all public bodies. (The card is separate from the BAJ Membership Card).

The Authority's definition of eligibility is that the card is available to people earning the majority of their income from journalism who "need to identify themselves in public."

The card is an electronically imaged plastic card. It bears the BAJ logo, the word **PRESS** in bold letters, the holders name, photograph, job title and card number. The card is valid for two years.

**The cost of a UK Press Card is £80.00 (£35.00 to BAJ members). Details of payment will be sent by email when/if your card is approved.**

- It is necessary to confirm your eligibility for the card. The cards give journalists recognition in sensitive situations, and they must be issued only to the right people.  
**Staffers** must, therefore, provide a letter from an executive in their office on office headed notepaper certifying their eligibility for the UK Press Card.  
**Freelancers** must provide a letter from a senior executive on the publication/radio/TV network/website for which they regularly work on the organisation's original headed notepaper. The letter has to certify their eligibility for the UK Press Card. Proof of identity document, e.g. certified copy of a passport, driving licence etc. together with proof of home address. and samples of verifiable published paid journalistic work.
- The letter is a requirement of the UK Press Card Authority. You do not have to say to an executive that you want the letter for the BAJ. You can just say you need it to apply for the UK Press Card.
- Complete and return forms 1 and 2 using black ink and **BLOCK CAPITAL** letters for all fields.
- You need to choose your own **Personal Identification Code**. It must be six digits or letters. Use a date of birth, a name, part of a name, a code word, or anything you can remember.
- Please note that your personal information contained within this form will need to be collected and processed for administrative purposes and to allow your application for a UK PRESS CARD to be managed and processed. Your personal information will accordingly (in order to enable us to provide you with your UK PRESS CARD) be subject to collection, use, storing, processing and transfer to third parties to meet legal, statutory, legitimate interests and contractual obligations. The BAJ Privacy Notice and UK Press Card Authority Privacy Notice are attached to this form.
- **You must supply a verified Passport style photograph of yourself with your application**

The UK Press Card Authority operates a 24-hour Verification Hot-line. Anyone querying a journalist's identity can call the phone number on the back of the card and ask for the PI Code listed against your card number. Be ready to give your PI Code for corroboration. Should you ever lose your card or have it stolen, let BAJ know immediately and report it to your local Police office.

## **UK PRESS CARD AUTHORITY PRIVACY NOTICE**

British Association of Journalists are registered with the Information Commissioner's Office and act as the data controller in the collection, use, storing, protection and transfer of your personal information. The person in charge of ensuring your data protection rights is Annette Raitz, and can be contacted on our main office number.

**BAJ** collect your personal information to meet our legal, statutory and contractual obligations to enable us to provide you with your UK PRESS CARD. We will never collect any unnecessary personal data from you and do not process your information in any other way

***The personal data that we collect from and process for you is: –***

- Name
- Home Address
- Telephone Number
- Mobile Number
- PIN / Password to identify yourself as required by the authorities (Police if required)
- Date of Birth
- Job Title
- Employing organisation (if required)

**BAJ** takes your privacy very seriously and will never disclose, sell or share your data, unless required to do so by law. We only retain your data for as long as is necessary.

You have the right to access any personal information that **we** hold or process about you and to request information about: –

- What personal data we hold
- The purposes of the processing
- The categories of personal data concerned
- The recipients to whom the personal data has/will be disclosed
- How long we intend to store your personal data for

If you believe that we hold any incomplete or inaccurate data about you, you have the right to ask us to correct and/or complete the information and we will strive to update/correct it as quickly as possible, unless there is a valid reason for not doing so, at which point you will be notified.

Your also have the right to request erasure of your personal data or to restrict processing in accordance with the data protection law, however if this right, is exercised then your UK PRESS CARD will no longer be valid

If we receive a request for any of the above rights, we may ask you to verify your identity before acting on the relevant request; this is to ensure that your data is protected and kept secure

We do not share or disclose any of your personal information without your consent, other than for the purposes specified, unless there is a legal requirement or to enforce our terms and conditions.

**BAJ** do not transfer your data outside of the EEA for the purpose of the Press Card Authority application and will always ask for consent if this becomes a requirement.

We utilise the following processors who act on our behalf to provide the card production and the daily preparing of the data for the PRESS CARD VERIFICATION service. They act in accordance with instructions from us as part of the UK Press Card Authority, Gatekeepers committee and comply fully with this and their own privacy notice, the data protection laws and any other appropriate confidentiality and security measures.

The Press Association provide the virtual 24-hour call centre for the PRESS card verification line. Each day they receive an up to date list of all valid cards with the associated PIN number / password (nothing else) from Custom Card - IBS. They will then confirm to the police or who ever requests information whether card is valid or not after the proper holder has given their password. The validity of the card is then confirmed or denied and that is all that is given to the person requesting the verification

The above parties do not process your information for any other purpose other than issuing, verifying and/or administering your press card and will never share or disclose your data save for where it is necessary for the purpose of issuing, verifying and/or administering your press card.

The companies in this notice take your privacy seriously and take every reasonable measure and precaution to protect and secure your personal data. We work hard to protect you and your information from unauthorised access, alteration, disclosure or destruction and have several layers of security measures in place,

**BAJ and Custom Card - IBS** only process your personal information in compliance with this privacy notice and in accordance with the relevant data protection laws.
